**I acknowledge and have read, understood and agree to the above Waiver, Release and Indemnity.** I warrant that my child is physically fit to participate in the Conservation Day Camp, and I hereby understand that he/she will follow the rules and regulations as set out by the organizers of the Conservation Day Camp, and that by not adhering to the rules and regulations, he/she may not only endanger himself/herself, but permission may or will be revoked and he/she will be asked to leave the premises.
