## 15. Forest Management Report

**Discussion:** Staff identified that of the 30,000 acres that Quinte Conservation owns, approximately 25,000

are under a Management Forest Agreement (MFA). The existing agreements need to be updated in 2017. There has been a program approved to hire two forest technicians to collect detailed information on Quinte Conservation forested lands. The data that will be collected will be used to develop forest management prescriptions and to update the Quinte Conservation forest management plans. The completed plans will be for the period of January

1, 2018 to December 31, 2037.

Staff reported that if Quinte Conservation is not successful in recruiting two forest technicians to collect the data staff will have to apply for funding to have a consultant do it or complete the data collection in house in order to complete the required new agreement.

Staff indicated that this project was not in the budget however QC should proceed with the completion of updating the agreements in order to prevent a loss in tax reductions on these properties. The cost could be as much as \$60,000; however staff are applying for assistance. This project will be a special levy item in 2017 budget if necessary.

At this point the owners are allowing dog walkers and other members of the public to continue using it. The Scouts have up to this point been using this location for their annual Jamborees and the owner with some persuasion is going to continue to let this activity continue.

Quinte Conservation staff will continue to communicate with legal representation to figure out what the best solution for this situation could be.

It was noted that Quinte Conservation could possibly purchase the property and also that the property portion that is not owned by Quinte Conservation is not accessible without going through QC owned property.
