16c. Strategic Planning Committee - Cost of Living

Discussion: A board member asked if this motion means that the budget will increase regardless of need.

Staff replied that for 2016 the cost of living was 1.5% but the levy was held at a 0% increase which puts Quinte Conservation behind and the motion is saying that the board would strive to have a cost of living increase.

A board member stated that this was not convincing and noted they would philosophically vote against it.

Staff noted that this motion would only mean that there is a culture of not having a 0% increase in levy if the cost of living increase is higher.

A board member said it is the job of Quint Conservation staff to convince the municipalities that their budget needs to be increased.

A board member noted that an overall increase of 1.5% is reasonable but due to the funding formula it means a 4.5% increase to some municipalities and as such that board member cannot support this motion under the current funding formula.

A board member asked if this motion is the same as making sure the budget meets the needs of the organization.

A board member said that Quinte Conservation staff should fully express to the board what the costs are and what funds are required.

A board member noted that this motion is attempting to set a bench mark for providing services.

A board member noted that the City of Belleville staff came forward with a budget that required a 5-6% increase and were able to achieve significant savings when it was sent back for them to work on.

streamflow is 15-20% of normal.

dams.
