13. Summary of the December Delegation (Motion to Receive)

Board Member said that Quinte Conservation should consider modifying the criteria in which the proposals are received. Energy dispossession needs to be addressed as new criteria for proposals.

Staff answered that Quinte Conservation don't disagree but the issue is that a lot of these shoreline structures are replacements of existing. Also, the Shoreline Management Plan will help with some of these concerns and have guidelines for this type of work.

Staff said that with new shoreline structures Quinte Conservation wants them to be sloped to allow for energy dispossession but this is not always possible with the amount of room on the property.

Board Member said Quinte Conservation doesn't have enough staff to inspect properties after we issue the permit and there is no point in issuing if we are not going to inspect as landowners will not always do what they say and are allowed to do.

Board Member asked if regular photo updates could be asked as a requirement with the issuance of a permit and if the applicant does not submit photos it can be revoked.

Board Member asked if the applicant is required to provide a pour date.

Staff answered that this can be difficult because the permit is valid for two years.

Board Member asked if Quinte Conservation could require better materials for shoreline protection work.

Staff answered that Quinte Conservation does not require specific material because of cost restraints for applicants.

Board Member asked if Quinte Conservation could require a coastal engineer for shoreline protection work.

Staff answered that this is possible and that some other Conservation Authorities require this but it is costly for the applicants.

Discussion followed on this topic.

Staff said Ministry used to require a sign-off from adjacent landowners as a part of its application but now it is not required.

Board Member asked for staff to look into this and bring to next meeting.

Staff added that there are issues with staff time.

Board Member suggested to increase the permit fees to allow for more staff in permitting.

Board Member agreed that we need enforcement and more staff for applicants to comply.

15. Municipality of Centre Hastings Lease Renewal Request (Motion to Approve)

Staff explained report.

The Municipality of Centre Hastings is interested in renewing the lease of Whytock Park located at 350 Russell Street North because there are structures on the property that the Municipality owns.

This lease does not affect staff or access to the plantation on the property.

Board Member asked if there is any wording in the lease that required the Municipality to notify Quinte Conservation when new infrastructure is added.

Staff said item four (4) in the lease mentions this. The Municipality cannot put any new structures on the property without Quinte Conservation approval.

Board Member asked if the Municipality would consider purchasing the property.

Staff said this discussion did come up but the process is lengthy. The decision was to renew the lease and look into the possibility of purchasing the property in the future.

Board Member asked about the comparison between the Hasting Prince Edward District School Board (HPEDSB) and the Algonquin Lakeshore Catholic District School Board (ALCDSB) it is currently 50/50 responsibility but HPEDSB has more buildings on the property and that should reflect the user ship.

Staff answered that each school board having their own agreement with Quinte Conservation is more appropriate and fair and will reflect own usage.

Board Member said that HPEDSB has a staff member at the HR Frink Centre 5 days a week as opposed to ALCDSB only having a staff member 5 days every two weeks which would indicate HPEDSB would have more usage.

Staff answered that this will not impact the 2021 budget. Investing in Depot Lakes Campground has been on the list of things to do but has never been high enough priority to be completed. Money was saved last year at Depot Lakes Campground due to fewer students and shorter season.

Board Member asked the timeline of the listed projects.

Staff answered that we are waiting for approval for projects to move forward.

Board Member asked if the money was operational Quinte Conservation may have to sustainability reserve and pull out the money from it.

Staff answered that we can do that if the that is what the Board wants.
