6. Proposed Amendment to the Directors Technical Rules (Motion to Receive)

Quinte Conservation received the proposed amendments on August 11, 2020. There was a three-month consultation instead of the normal thirty-day consultation due to COVID-19.

Staff stated that Quinte Conservation still has questions for the Ministry regarding some of the proposed amendments.

Board Member asked if alvar and bedrock would be classified as an impermeable surface.

Staff answered that natural features are not included in the Ministry's rules but if the desire exists from a specific municipality, it is up to the source protection committee whether that additional ask is included in source protection plan policies.

Board Member asked about existing subdivisions and if they would have to follow the new amendments if the work has already started or has already received the necessary approvals.

Staff answered that more of the time if a project has been approved then it is classified as existing and the old policy would be grandfathered in with the existing conditions.
